**Subject:** Launch of mPension Manipur Application to enable online updation of digital photographs in respect of Pensioners/Family Pensioners: regarding.

**No. FX-26/9/2020-e-FD:** As per extant practice, every State Government Pensioner/Family Pensioner is required to visit the concerned Treasury Office every six months to update his/her digital photograph as per Finance Department's O.M. No.10/4/2006-FX(PEN) dated 17<sup>th</sup> December, 2020. This practice has posed difficulty for aged and infirmed pensioners and for those State Pensioners/Family Pensioners residing outside the State. Further, the COVID-19 Pandemic has added inconvenience to this class of pensioners.

2. In order to overcome these difficulties, the Government of Manipur has decided to launch an application – "**mPension Manipur**". This application is developed by National Informatics Centre, Manipur to facilitate seamless updation of digital photograph of Pensioners through smartphone or desktop/laptop at their residence without the requirement to visit any of the Treasury Offices. Through the application, Pensioners/Family Pensioners:

- (a) can upload photographs from their homes;
- (b) can check validity of their last photographs;
- (c) can send queries and feedback to their concerned Treasury Offices;
- (d) Pensioners will receive messages from Treasury in response to their queries and information on status of updation/validity of photograph.

3. The details of the mPension Manipur are detailed below:


- (a) The application can be installed by any pensioners or their family members on any smartphone (Android or iOS) or any desktop computer/laptop having a webcam;
- (b) The application has inbuilt software for checking the status of the pensioners so that previously taken photographs cannot be uploaded;
- (c) At the Treasury Office, the concerned Treasury Officer/Sub Treasury Officer shall check the uploaded photographs and details with the existing photograph/details of the Pensioner/Family Pensioner. In case of rejection, the concerned Pensioner/Family Pensioner shall receive reasons for the same from concerned Treasury Officer/Sub Treasury Officer;
- (d) **The updation of the photos of the Pensioners/Family Pensioners through the application will be done every six months.** However, those who are willing to physically visit the Treasury Offices in lieu of the procedure outlined in the O.M. can also do so;

No. 4/46/2006-DTA :- It is hereby informed to all pensioners/family pensioners receiving pension through the Treasury/Sub-Treasury offices of Manipur that an online solution "mPension Manipur" application has been introduced by the Government vide order No. FX-26/9/2020-e-FD dated 04-01-2021 whereby the pensioner/family pensioner can make their periodic photograph updation online through a smartphone or a desktop/laptop, from their own residences. 

The updation of photos through the application is to be done every six months.

Those pensioners/family pensioners who are willing to visit the Treasury/Sub-Treasury offices instead of using the above web application can continue to do so. Further, for instances of first payment of pension, conversion to family pension etc., the claimant will still need to visit the Treasury office for the first time.
